**RESOLUTION APPROVING REVISED ATTACHMENT A OF THE NEIGHBORHOOD STABILIZATION PROGRAM CONTRACT BETWEEN THE CITY OF DES MOINES AND THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT**

WHEREAS, Section 2301 of the Housing and Economic Recovery Act of 2008 created the Neighborhood Stabilization Program (NSP); and,

WHEREAS, Congress allocated \$3.92 billion of Community Development Block Grant funds to the NSP for state and local governments to provide emergency assistance redeveloping abandoned and foreclosed homes; and,

WHEREAS, the State of Iowa submitted a plan to HUD which allocated \$3.9 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa stating how it would allocate these funds; and,

WHEREAS, the State of Iowa approved the City's plan to allocate the funds; and,

WHEREAS, the City has allocated over 95 percent of available NSP funds; and,

WHEREAS, IDED has awarded the City of Des Moines an additional \$264,481 of additional NSP funds,

WHEREAS, these funds will be used to continue implement of the approved Neighborhood Stabilization Program plan.
