APPROVING AND AUTHORIZING EXECUTION OF AN IOWA EMERGENCY CARDIAC CARE GRANT MEMORANDUM OF UNDERSTANDING WITH CHI-IOWA-CORP (MERCY MEDICAL CENTER – DES MOINES)

WHEREAS, CHI-Iowa-Corp., d/b/a Mercy Medical Center-Des Moines, received a grant from the United States Human Resources and Services Administration through the Health Care and Other Facilities Grant Programs to be used for purchasing equipment that will help the Emergency Medical Services (“EMS”) transporting acute myocardial infarction patients to a hospital able to perform percutaneous coronary intervention; and

WHEREAS, Mercy Medical Center-Des Moines awarded a grant to the City of Des Moines through its Fire Department of 12 Lifenet modems and 5 year transmission subscriptions for each which will allow Mercy and the Fire Department EMS to work toward improving the speed at which heart attack patients are diagnosed and treated; and

WHEREAS, Mercy Medical Center-Des Moines has prepared a Memorandum of Understanding for such grant to be administered by the Fire Department, a copy of which is on file in the City Clerk’s Office; and

WHEREAS, the Memorandum of Understanding provides that, after the grant period ends on August 31, 2010, ownership of the Lifenet modems will be transferred to the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Iowa Emergency Cardiac Care Grant Memorandum of Understanding with CHI-Iowa-Corp., d/b/a Mercy Medical Center-Des Moines for 12 Lifenet modems and 5 year transmission subscriptions for each is hereby approved and the Chief of the Fire Department is hereby authorized and directed to sign said Memorandum of Understanding on behalf of the City of Des Moines and the City Clerk is directed to attest to his signature.
