APPROVAL OF CONTRACT WITH HOME OPPORTUNITIES MADE EASY, INC. (HOME, INC.) FOR OPERATING SUPPORT AS A DESIGNATED COMMUNITY HOUSING DEVELOPMENT ORGANIZATION (CHDO)

WHEREAS, the City of Des Moines is a Participating Jurisdiction as defined by HOME Investment Partnerships Program (HOME) regulations and has been so designated by the U.S. Department of Housing and Urban Development (HUD) pursuant to 24 CFR Part 92.105; and

WHEREAS, a participating jurisdiction must reserve not less than 15% of the HOME allocation for investment in housing to be developed, sponsored, or owned by Community Housing Development Organizations (CHDO's) and may commit an additional 5% of its HOME allocation for CHDO operating costs, not to exceed \$50,000, under the requirements of 24 CFR 92.208; and

WHEREAS, on July 14, 2010 by Roll Call 10-927, the City Council approved the 2010 Program allocations for the HOME Program operated by the Community Development Department which included \$50,000 for CHDO operating costs; and

WHEREAS, on December 7, 2009 by Roll Call 09-2191, Home Opportunities Made Easy, Inc. (HOME, Inc.) was found to meet CHDO requirements set forth in 24 CFR 92.2 and that finding was forwarded to HUD; and

WHEREAS, The U.S. Department of Housing and Urban Development (HUD) has accepted the City Council certification and designated HOME, Inc. as a CHDO.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, the following:

- 1. The Home Investment Partnerships (HOME) Agreement between the City of Des Moines and HOME, Inc. is hereby approved; and
2. The Community Development Director of the City of Des Moines is authorized to execute the HOME contract document on behalf of the City in such form approved by the Legal Department.
