WHEREAS, the Police Department requested the Finance Department Procurement Division to purchase eight (8) 4-Panel Ballistic Enclosures and Anti-fragmentation Covers for the Universal Blast Containment Systems for Iowa's Explosive Ordinance Disposal (EOD) Task Force Teams, one of which will be retained by the City of Des Moines Bomb Squad; and

WHEREAS, the Procurement Administrator has determined that such equipment is only available from Allen Vanguard Technologies Inc., (USA) 21720 Red Plum Drive, Ste 187, Ashburn, VA 20147, (Canada) 2400 St. Laurent Blvd, Ottawa, ON K1G 6C4, David Luxton Founder, Chief Executive Officer, President and Executive Director, the sole manufacturer and distributor; and

WHEREAS, Municipal Code section 2-726 (a)(7) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective; and

WHEREAS, funding is available from Recommended Budget June 30, 2010, Page 288, FY2008 (EOD) Iowa's Bomb Squad Task Force Program Grant, SP751, POL985304; Homeland Security Grant Program in the amount of \$52,400.00.

WHEREAS, the Procurement Administrator approves of and recommends the sole source purchase from Allen Vanguard Technologies Inc., (USA) 21720 Red Plum Drive, Ste 187, Ashburn, VA 20147, (Canada) 2400 St. Laurent Blvd, Ottawa, ON K1G 6C4;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the non-competitive purchase of the 4-Panel Ballistic Enclosures and Anti-fragmentation Covers for the Universal Blast Containment Systems, from Allen Vanguard Technologies Inc. for a total cost of \$52,400.00, which is all reimbursable to the City through the FFY2008 Homeland Security Grant Program.
