**APPROVING CHANGE ORDER NO. 1 WITH REILLY CONSTRUCTION COMPANY, INC. AND

FOR A TOTAL NOT TO EXCEED \$53,106**

WHEREAS, the process for procurement of bids or quotations for public improvements is set forth in the Summary of Bidding/Contracting Process Changes for Construction of Public Improvements Policy that was approved by the City Council on February 12, 2007 by Roll call no. 07-291; and

WHEREAS, that Policy requires the procurement of competitive quotations for projects is \$65,000.00 or below; and

WHEREAS, in this instance the City Engineer recommends that the Council waive that policy to accommodate the completion time required for the private improvements being made.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

That it hereby waives the Summary of Bidding/Contracting Process Changes for Construction of Public Improvements Policy that was approved by the city Council on February 12, 2007 by Roll call No. 07-291 and that the attached Change Order No. 1 between the City of Des Moines and Reilly Construction Company, Inc. and Subsidiaries, Chris R. Reilly, President, 110 Main Street, PO Box 99, Ossian, IA, 52161, for additional work on the 33rd Street Sewer Separation project, in an amount not to exceed \$53,106, be and is hereby approved, and the City Manager is authorized and directed to execute said change order.
