## ACCEPTING PROPOSAL FROM CONFLUENCE FOR CONCEPT PLANNING SERVICES TO EXAMINE REDEVELOPMENT OPTIONS FOR THE SOUTHERN MEADOWS APARTMENTS AND AUTHORIZING CITY MANAGER TO NEGOTIATE AND EXECUTE CONTRACT FOR SAME IN THE AMOUNT NOT TO EXCEED \$24,950

WHEREAS, Section 2301 of the Housing and Economic Recovery Act of 2008 created the Neighborhood Stabilization Program (NSP); and,

WHEREAS, Congress allocated \$3.92 billion of Community Development Block Grant funds to the NSP for state and local governments to provide emergency assistance redeveloping abandoned and foreclosed homes; and,

WHEREAS, the State of Iowa received \$21.6 million to allocate to cities within the State; and,

WHEREAS, the State of Iowa submitted a plan to HUD which allocated \$4.2 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa to outline how to allocate these funds; and,

WHEREAS, the City has identified the Southern Meadows Apartments at 2800 SE 8<sup>th</sup> St. as a large scale project that could benefit from the use of these funds; and,

WHEREAS, on July 9, 2010, a Request for Proposals (RFP) for consultant services to prepare redevelopment concept plans for the site of the Southern Meadows Apartments was issued by the Procurement Division of the Finance Department; and

WHEREAS, the Procurement Administrator solicited proposals by advertising and mailing RFP V11-006 to twenty (20) potential proposers with six (6) proposals received; and

WHEREAS, an Evaluation and Selection Committee has reviewed the proposals and has recommended that a contract for such services be awarded to Confluence, Chris Della Vodova, Principal, 1300 Walnut Street, Suite 200, Des Moines, Iowa 50309.


