WHEREAS, the School Board Room is being relocated and moved to another location within Central Campus, with construction of the new school Board Room scheduled to be completed by September 2011; and

WHEREAS, the Des Moines City Council Chambers are available on the first and third Tuesdays from October 2010 through August 2011 and the existing Mediacom cable feed in the Council Chambers is compatible with the School District's requirements to televise their Board meetings; and

WHEREAS, the School District desires to use the City Council Chambers for their Board meetings for the period from October 5, 2010 until August 31, 2011: and

WHEREAS, the City Council deems it advisable to allow such use of the Council Chambers by the School District.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above described use of the City Council Chambers by the Des Moines Independent Community School District is hereby approved and the City Manager is hereby authorized and directed to negotiate and execute a Use Agreement for same, subject to approval as to form by the Legal Department, and the City Clerk is
