RESOLUTION FIXING DATE FOR A MEETING ON THE AUTHORIZATION OF A LOAN AGREEMENT AND ISSUANCE OF NOT TO EXCEED \$1,600,000 AVIATION SYSTEM REVENUE CAPITAL LOAN NOTES OF DES MOINES, IOWA, AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is the recommendation of the Aviation Director, subject to approval of the Des Moines International Airport Board, that the City of Des Moines, Iowa should provide for the authorization of a Loan Agreement and the issuance of Aviation System Revenue Capital Loan Notes, in the amount of not to exceed \$1,600,000, as authorized by Sections 384.24A and 384.82, Code of Iowa, as amended, for the purpose of providing funds to pay costs as hereinafter described; and

WHEREAS, the Loan Agreement and Notes shall be payable solely and only out of the net earnings of the Des Moines International Airport, and shall not be general obligations of the City or payable in any manner by taxation and the City shall be in no manner liable by reason of the failure of the net revenues to be sufficient for the payment of the Notes; and

WHEREAS, before a Loan Agreement may be authorized and Aviation System Revenue Capital Loan Notes issued to evidence the obligation of the City thereunder, it is necessary to comply with the provisions of the City Code of Iowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the Council proposes to take action for the authorization of the Loan Agreement and Notes and to receive oral and/or written objections from any resident or property owner of the City to such action; and

WHEREAS, it is also necessary that a hearing be held under Section 147 of the Internal Revenue Code of 1986 upon the proposal to issue the Notes as tax-exempt obligations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:



Section 1. That this Council meet in the Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at <u>5:00</u> o'clock <u>P</u>.M., on the <u>2576</u> day of October, 2010, for the purpose of taking additional action for the authorization of a Loan Agreement and the issuance of not to exceed \$1,600,000 Aviation System Revenue Capital Loan Notes, the proceeds of which will be used to provide funds to pay a portion of the costs of construction of certain improvements to the heating, cooling and ventilation systems in the terminal and concourse areas at the Des Moines International Airport, 5800 Fleur Drive, Des Moines, Iowa.

Section 2. That the City Clerk is hereby directed to cause at least one publication to be made of a notice of said meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said City, said publications to be not less than fourteen clear days nor more than twenty days before the date of said public meeting on the issuance of the Notes.

PUBLIC NOTICE is hereby given that the Council of the City of Des Moines, Iowa, will hold a public hearing on the 257h day of October, 2010, at 5:00 o'clock 2.M., in the Council Chambers, City Hall, 400 Robert D.
