**APPROVING INITIAL LIHEAP (LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM)
CONTRACT WITH IOWA DEPARTMENT OF HUMAN RIGHTS,
DIVISION OF COMMUNITY ACTION AGENCIES FOR ENERGY-RELATED ASSISTANCE
FOR LOW-INCOME PERSONS FROM OCTOBER 1, 2010 TO SEPTEMBER 30, 2011**

WHEREAS, Des Moines Community Action Agency, Housing Services Department, is charged with administering the Low-Income Home Energy Assistance Program (LIHEAP); and

WHEREAS, the Iowa Department of Human Rights, Division of Community Action Agencies has now forwarded Contract No. LIHEAP-11-07 on file with the City Clerk as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, Contract No. LIHEAP-11-07, by and between the Iowa Department of Human Rights, Division of Community Action Agencies, and the City of Des Moines, allocates \$58,062 to the City of Des Moines for the provision of energy-related assistance to low income persons during the period from October 1, 2010 through September 30, 2011; and

WHEREAS, approval of Contract No. LIHEAP-11-07 is in the best interest of the City as it will provide for the increase in energy-related assistance available for low-income residents of Des Moines.



BE IT FURTHER RESOLVED that the City Manager is authorized and directed to execute any changes in the terms, conditions, or amounts specified in this contract and the Housing Services Director or his designee is designated to sign all fiscal and program forms required by this contract.




