## PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON GRAND AVENUE - 19TH STREET TO POLK BOULEVARD OLDER DRIVER-PEDESTRIAN TRAFFIC CONTROL; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS IOWA SIGNAL INC., WAYNE LESLEY, PRESIDENT, \$147,408.01

WHEREAS, on September 13, 2010, under Roll Call No. 10-1432, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Grand Avenue - 19th Street to Polk Boulevard Older Driver-Pedestrian Traffic Control, 04-2009-011 CS-TSF-1945(748)--85-77 The improvement includes traffic signalization modifications on Grand Avenue at 28th, 31st, 35th, 37th, and 42nd Streets in Des Moines, Iowa in accordance with the contract documents including Plan File Nos. 523-43/54

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
