## RECOMMENDING APPROVAL OF DES MOINES MUNICIPAL HOUSING AGENCY (DMMHA) REPLACEMENT HOUSING FACTOR FUND PROPOSAL AND AGENCY PLAN AMENDMENTS

WHEREAS, the Des Moines Municipal Housing Agency (DMMHA) is charged with providing quality, affordable housing; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has established a Replacement Housing Factor (RHF) fund providing funding to Public Housing Agency's for replacement of disposed Public Housing units; and

WHEREAS, the DMMHA has established an RHF fund proposal to demolish eleven (11) scattered site Public Housing units and construct a minimum of ten (10) new homes on the Agency's owned land; and

WHEREAS, the following properties are being recommended for demolition and/or redevelopment:
