RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE PROPOSED URBAN RENEWAL PLAN FOR THE SOUTHEAST ECONOMIC DEVELOPMENT DISTRICT URBAN RENEWAL AREA

WHEREAS, the City Council desires to consider the use of its urban renewal powers to assist in the development of the approximately 913 acre area that is generally located between SW 9th Street, Army Post Road, SE 14th Street and County Line Road;

WHEREAS, the City Manager has prepared an urban renewal plan which seeks to enhance private development of this commercial, office and retail urban renewal area though provision of economic development financial assistance that will be provided in part with tax increment financing revenues to be generated in the proposed urban renewal area;

WHEREAS, the proposed plan is titled "Southeast Economic Development District Urban Renewal Plan" and is on file and available for public inspection in the office of the City Clerk;

WHEREAS, the Urban Design Review Board shall review the proposed urban renewal plan at its regular meeting on November 16, 2010, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council;


WHEREAS, the City Plan and Zoning Commission shall review the proposed urban renewal plan at its regular meeting on November 18, 2010, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. A public hearing shall be held before the City Council to consider the proposed Urban Renewal Plan for the Southeast Economic Development District Urban Renewal Area at 5:00 p.m. on December 6, 2010, in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa.
- 2. The City Clerk is authorized and directed to publish notice of said public hearing in the form attached hereto as Exhibit "B" in the Des Moines Register on November 18, 2010.
- 3. The proposed urban renewal plan is hereby submitted to the City Plan and Zoning Commission for its review and recommendation as to the plan's conformity with the Des Moines 2020 Community Character Land Use Plan, as revised to date, with said written recommendation requested to be received by the City Council prior to the date of public hearing.
- 4. The proposed urban renewal plan is hereby submitted to the Urban Design Review Board for its review and recommendation, with said written recommendation requested to be received by the City Council prior to the date of public hearing.
