**APPROVAL OF THE 2010 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CONTINUUM OF CARE PROGRAM APPLICATION**

**WHEREAS**, its meeting on September 13, 2010 by Roll Call No. 10-1471, the City Council adopted the recommendations of the Polk County Housing Continuum (PCHC) Board for the 2010 Supportive Housing Program (SHP) priorities and procedures to be applied to the Continuum of Care Program application; and

**WHEREAS**, at its meeting on October 13, 2010 the PCHC Board approved a motion to adopt the 2010 SHP application as recommended by the Continuum of Care Committee and forward it to the City Council for approval; and

**WHEREAS**, in response to a Notice Of Funding Availability (NOFA) for Homeless Assistance Grants published in the Federal Register on September 20, 2010, to supplement funding for local homeless programs, the City's Finance Department in collaboration with the Continuum of Care Committee of the Polk County Housing Continuum Board prepared a SHP application for \$2,970,787 in Supportive Housing Program and Shelter Plus Care funds, which application is on file in the City Clerk's Office and by this reference made a part hereof, to be submitted to HUD for funding approval; and

**WHEREAS**, the application is based upon the City's Continuum of Care strategy, whereby Continuum of Care funds would provide needed services to homeless persons in Des Moines and address high priority service gaps within the parameters of the priorities and procedures recommended by the PCHC Board and adopted by the City Council.

**NOW, THEREFORE, BE IT RESOLVED BY THE** City Council of the City of Des Moines, Iowa, that the above-referenced Continuum of Care Program application and certifications thereto are hereby approved and ratified, and the City manager or his designee is hereby directed to execute any necessary documents and submit the application to HUD.




