RESOLUTION APPROVING FIRST AMENDMENT TO CITY ECONOMIC DEVELOPMENT LOAN TO STICKEL ENTERPRISES, LLC FOR AN ECONOMIC DEVELOPMENT PROJECT AT 2925 INGERSOLL AVENUE, DES MOINES

WHEREAS, on February 9, 2009, by Roll Call No. 09-196, City Council approved a \$165,000 City Economic Development Loan to Stickel Enterprises, LLC (Jeffery E. Stickel, Manager, 408 Foster Drive, Des Moines) to assist in the construction of a new, three-story, 12,400 square foot, multi-tenant commercial building at 2925 Ingersoll Avenue, Des Moines, Iowa; and

WHEREAS, the project encountered over \$400,000 in increased construction costs of which \$200,000 was directly related to increased site development costs in providing required traffic circulation and parking; and

WHEREAS, the project reclaimed unimproved ground between 29th Street and the project site and crossed two neighboring commercial properties to construct traffic circulation and 56 parking spaces. The access and parking is also used by patrons of the two commercial buildings between 29th Street and the Stickel Project; and

WHEREAS, to assist in completing the project financing, the City's Office of Economic Development is proposing to increase the City loan by \$85,000 at an interest rate of three percent (3%) per annum to be amortized over 20 years with a five-year maturity. The additional loan will be secured by a subordinate real estate mortgage on the project property and the personal guarantee of Jeffery E. Stickel; and

WHEREAS, the City desires to continue to participate in a public and private investment in the project pursuant to Iowa Code Chapter 15A, involving the economic stabilization of and redevelopment within the City and the Ingersoll Avenue Pedestrian Retail Corridor which will involve the expansion of the City's commercial tax base and the creation of new jobs and income; and

WHEREAS, the public gains and benefits generated from this economic development activity are warranted in comparison to the amount of funds invested; and

WHEREAS, the Developer has obtained all other public and private financing commitments; and

WHEREAS, the Developer has executed the attached First Amendment to the City Economic Development Loan Agreement, the Promissory Note, Mortgage and Personal Guaranty; and

WHEREAS, the City Council finds the form of each document to be acceptable.

- 4. Following full execution of the attached documents, City staff is authorized to perform all City obligations under the First Amendment to the City Economic Development Loan Agreement including the disbursal of City funds pursuant to the terms of the City of Des Moines First Amendment to Loan Agreement in the amount of \$85,000; and to perform all other City of Des Moines obligations pursuant to the terms and conditions stated the City Loan Agreement and First Amendment to the City Economic Development Loan Agreement, the Promissory Note, Mortgage and Personal Guaranty documents.
