APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR STORM SEWER IMPROVEMENTS, 1375 E. COURT AVENUE, BETWEEN J.P. CULLEN & SONS, INC. AND STATE OF IOWA, DEPARTMENT OF ADMINISTRATIVE **SERVICES**

WHEREAS, on August 24, 2009 under Roll Call No. 09-1525, the City Council approved a private construction contract in the amount of \$89,925.00, between J.P. Cullen & Sons, Inc., David J. Cullen, President and CEO, P.O. Box 1957, Janesville, WI, 53547-1957 - as Contractor, and State of Iowa, Department of Administrative Services, Ray Walton, Director, General Services Enterprise, 1305 E Walnut, 3rd Floor, Des Moines, IA, 50319 as Owner, for construction of Storm Sewer Improvements described as construction of storm sewer at the new office building for the Iowa Utilities Board and Office of Consumer Advocate, 1375 E Court Avenue, Des Moines, Iowa, in accordance with the contract documents including plan File Nos. 507-135/138, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

Cullen & Sons, Inc. and State of Iowa, Department of Administrative Services, which were approved under Roll Call No. 09-1525, dated August 24, 2009, be received and filed; and that completion of said Storm Sewer Improvements described as construction of storm sewer at the new office building for the Iowa Utilities Board and Office of Consumer Advocate, 1375 E Court Avenue, Des Moines, Iowa, in accordance with the contract documents including plan File Nos. 507-135/138, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
