**APPROVING AND AUTHORIZING THE EXECUTION OF
IOWA JOBS PROGRAM GRANT AWARD AGREEMENT WITH THE
IOWA JOBS BOARD AND
THE IOWA FINANCE AUTHORITY
FOR \$2,100,000 FOR THE CENTRAL PLACE LEVEE REPAIR**

WHEREAS, on July 27, 2009 by Roll Call No. 09-1395, the City Council authorized submittal of the Central Place Levee Repair project application to the Iowa Finance Authority (IFA) under the Iowa's Infrastructure Investment Initiative (I-Jobs) Program; and

WHEREAS, on June 28, 2010, by Roll Call 10-1020, City Council approved the Project Partnership Agreement with the Department of the Army for construction of the Central Place levee improvements; and

WHEREAS, on June 28, 2010, by Roll Call 10-1022 and 10-1023, the City Council authorized submittal of the Central Place Levee Repair project application to the Iowa Finance Authority (IFA) under the Iowa's Infrastructure Investment Initiative (I-Jobs) Program and approval to pursue Smart Planning Principles; and

WHEREAS, on September 15, 2010, Governor Culver announced that the City of Des Moines had been awarded I-Jobs funding in the amount not to exceed \$2,100,000 for the Central Place Levee Repair project; and

WHEREAS, City staff has worked with IFA to negotiate a contract with the City that recognizes the Project Partnership Agreement between the City and the Department of the Army.

NOW, THEREFORE BE IT RESOLVED by the City of Des Moines, Iowa that the Iowa Jobs Program Grant Award Agreement between the Iowa Jobs Board and the Iowa Finance Authority (IFA) and the City of Des Moines in an amount not to exceed \$2,100,000 is hereby approved.

BE IT FURTHER RESOLVED That the Mayor is hereby authorized and directed to execute, said grant contract and other related documents on behalf of the City of Des Moines, Iowa and the Chief Deputy City Clerk is authorized and directed to attest to the Mayor's signature.
