AUTHORIZING CITY PARTICIPATION IN TRAFFIC SAFETY AND STUDENT DROP-OFF AREA IMPROVEMENTS AT CENTRAL CAMPUS, 1800 GRAND AVENUE, FOR DOWNTOWN SCHOOL AND AUTHORIZATION FOR THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE DES MOINES PUBLIC SCHOOLS

Whereas, Dr. Nancy Sebring, Superintendent of Des Moines Public Schools, has requested that the City participate in the combined improvements needed for a new student loading area for the Downtown School being relocated to the Central Campus at 1800 Grand Avenue; and

Whereas, Traffic and Transportation staff has worked closely with School District staff and their consultants to develop the most effective and safe area for parents to drop off and pick up their children at this new location; and

Whereas, the School District would pay for the design of the improvements (except for pedestrian and traffic signal improvements) and construction of the improvements inside the sidewalk, at an estimated cost of \$132,000; and

Whereas, the City and Des Moines Public Schools would enter into an Agreement noting the City would pay for the cost of constructing the new curb, an 11' or 12' sidewalk, storm sewer modifications and modifications to the pedestrian crossings and traffic signals, at an estimated cost of \$100,000 and would also provide the excess right-of-way to the School District.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, THAT THE CITY COUNCIL HEREBY APPROVES AND AUTHORIZES THE FOLLOWING:

- 1. That the letter request from Dr. Sebring be received and filed and the City Manager be authorized to negotiate an Agreement for participation in the improvements as outlined.
- 2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, for an on behalf of the City of Des Moines, Iowa, the Agreement subject to the City Engineering and Legal Departments review.
- 3. That the City Engineer, or his designee, is hereby authorized to administer the Agreement and is authorized and directed to execute and submit any documents related to administration of the Agreement, for an on behalf of the City of Des Moines, Iowa.
