**APPROVING SUPPLEMENTAL AGREEMENT NO. 4 TO THE COURT AVENUE/WATER STREET SEWER SEPARATION PROFESSIONAL SERVICES AGREEMENT WITH VEENSTRA AND KIMM, INC. FOR DESIGN SERVICES FOR MODIFICATION TO THE DESIGN OF THE COURT AVENUE PUMP STATION TO INCREASE THE LEVEL OF FLOOD PROTECTION BASED ON THE CORPS OF ENGINEERS DES MOINES RIVER REGULATED FLOW FREQUENCY STUDY, NOT TO EXCEED \$94,384.**

Veenstra Jr., P.E., President, 3000 Westown Parkway, West Des Moines, IA, for a total cost not to exceed \$94,384, based on hourly rates, to provide design services for modification to the design of the Court Avenue Pump Station to increase the level of flood protection based on the Corps of Engineers Des Moines River Regulated Flow Frequency Study for the Court Avenue/Water Street Sewer Separation Project, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.




