WHEREAS, the Police Department requested the Finance Department Procurement Division to purchase 2000 rounds of Disintegrating Projectile Avon projectiles, 4000 rounds of Black Powder Blank XBP12 Medium Blank projectiles, 2200 rounds of Enhanced Blank projectiles, and 1800 rounds of Low Velocity Clay projectiles for Iowa's Explosive Ordinance Disposal (EOD) Task Force Teams, of which 250 rounds of Disintegrating Projectile Avon projectiles, 500 rounds of Black Powder Blank XBP12 Medium Blank projectiles, 275 rounds of Enhanced Blank projectiles, and 225 rounds of Low Velocity Clay projectiles will be retained by the City of Des Moines Bomb Squad; and

WHEREAS, the Procurement Administrator has determined that such equipment is only available from L-Tech Enterprises, 509 Texas School Road, Eubank, Kentucky 42567, Larry Henderson, President, is the sole manufacturer and distributor; and

WHEREAS, Municipal Code section 2-726 (a)(7) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective; and

WHEREAS, funding is available from Recommended Budget June 30, 2010, Page 288, FY2008 (EOD) Iowa's Bomb Squad Task Force Program Grant, SP751, POL985304; Homeland Security Grant Program in the amount of \$28,480.00.

WHEREAS, the Procurement Administrator approves of and recommends the sole source purchase from L-Tech Enterprises, 509 Texas School Road, Eubank, Kentucky 42567;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the non-competitive purchase of 2000 rounds of Disintegrating Projectile Avon projectiles, 4000 rounds of Black Powder Blank XBP12 Medium Blank projectiles, 2200 rounds of Enhanced Blank projectiles, and 1800 rounds of Low Velocity Clay projectiles from L-Tech Enterprises for a total cost of \$28,480.00, which is all reimbursable to the City through the FFY2008 Homeland Security Grant Program.
