WHEREAS, on February 28, 2011 the Municipal Housing Governing Board approved the Municipal Housing Agency's amended and proposed annual budgets by Roll Calls $No_{11-0273}$ and 11-0274; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budget to the U.S. Department of Housing and Urban Development; and

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board of the City of Des Moines that the Mayor and City Clerk are hereby directed to certify the Municipal Housing Agency's 2011 budget amendment and 2012 proposed budget for all projects. Exhibit 1 is hereby approved and the Mayor is authorized and directed to execute the certification.
