**SET PUBLIC HEARING FOR APPROVAL OF THE 2010 HUD  
CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT  
(CAPER)**

WHEREAS, provisions under 24 CFR 91.520 regarding the implementation and management of the Consolidated Plan require the City to submit a Consolidated Annual Performance and Evaluation Report (CAPER) for the 2010 Program Year to the United States Department of Housing and Urban Development (HUD) no later than 90 days after completion of the 2010 Consolidated Plan Program Year; and

WHEREAS, provisions under 24 CFR 570.507 (a)(iii), require the City Council to conduct a public hearing regarding the CAPER for the 2010 HUD Consolidated Plan Program Year and to publish public notice of the hearing at least 15 days before it is held; and

WHEREAS, to fulfill the above-referenced requirements, this Council will conduct a public hearing during its regular meeting on March 28, 2011, at 5:00 p.m., to assess the 2010 HUD Consolidated Plan Program Year performance and publish a public notice of the same, on file with the City Clerk as Exhibit "A" and by this reference made a part hereof, in order to provide citizens with the opportunity to participate in the hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the public hearing be held before this Council during its regular meeting on March 28, 2011, at 5:00 p.m., to obtain citizen's views on the 2010 CAPER.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to publish the above-referenced public notice in the Des Moines Register on March 11, 2011.


