PUBLIC HEARING ON COURT AVENUE AND WATER STREET SEWER SEPARATION REGARDING:

- APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S
 ESTIMATE; AND
- 2. THE STATUS OF THE FUNDED ACTIVITIES UNDER IDED CONTRACT 08-DRI-032; ALSO RESOLUTION TO RECEIVE AND FILE BIDS; DESIGNATION OF LOWEST REPONSIVE, RESPONSIBLE BIDDER AS H & W CONTRACTING LLC, THOMAS L. HURD, PRESIDENT, \$3,977,311.75

WHEREAS, on February 14, 2011, under Roll Call No. 11-0165, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Court Avenue and Water Street Sewer Separation, 08-2009-003 08-DRI-032

The improvement includes construction of storm sewer ranging from 12" to 66" diameter, storm sewer structures, sanitary conflict structures, storm sewer jacked in place, watermain, traffic signal system, and portland cement concrete paving, subdrain, sidewalks, brick sidewalks and crosswalks, hot mix asphalt overlays, pavement markings, and miscellaneous associated work including cleanup and other incidental items; in accordance with the contract documents, including Plans File Nos. 527-024/101, located in Court Avenue from Water Street to 2nd Avenue, 2nd Avenue from Court Avenue to Grand Avenue, and Grand Avenue from 2nd Avenue to 3rd Street in downtown Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, on March 9, 2011, notice was also published of a hearing pursuant to the requirements of Section 508 of the Housing and Community Development Act of 1987, as amended. The purpose of the hearing is to discuss the status of funding for the proposed Court Avenue and Water Street Sewer Separation Project, Iowa Department of Economic Development Contract Number 08-DRI-032. This project is a part of the Court Avenue & Water Street Sewer Separation project, which will construct a separate storm sewer system and storm water pump station to serve this area. This area of downtown is currently served by a combined (storm and sanitary) sewer system, resulting in localized flooding during heavy rain events, especially during high river levels. The Court Avenue & Water Street Sewer Separation will construct a separate storm sewer system for this area of downtown that is currently served by a combined (storm and sanitary) sewer system. The combined sewer system is unable to adequately convey the storm water during heavy rain events resulting in localized flooding, especially during high river levels. The Court Avenue & Water Street Storm Water Pump Station, which is currently under construction, will provide the required pump station at the levee to pump storm water over the levee during high river levels when the gravity outlet to the river must be closed. The project is being funded in part through a Community Development Block Grant provided by the Iowa Department of Economic Development, I-JOBS II Targeted Disaster Relief Grant funds, and Des Moines Storm Water Utility Funds.
