CONDITIONAL APPROVAL OF PRIVATE CONSTRUCTION CONTRACT BETWEEN OPUS DESIGN BUILD, L.L.C. AND ODC GANNETT AVE, L.L.C.

FOR PAVING, SANITARY AND STORM SEWER IMPROVEMENTS IN AIRPORT BUSINESS PARK PLAT 3

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached contract documents for a Private Construction Contract between Opus Design Build, L.L.C., Dave Bangasser, President & CEO, 10350 Bren Road West, Minnetonka, MN, 55343 - as Contractor, and ODC Gannett Ave, L.L.C., Tom Shaver, President & CEO, 9700 West Higgins Road, Suite 900, Chicago, IL, 60018 - as Owner, for construction of Paving, Sanitary and Storm Sewer Improvements described as Airport Business Park Plat 3 located in the vicinity of SW 34th Street and Gannett Avenue, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 511-118/124, be and the same are hereby approved, subject to the following:

- 1. Receipt of Certificate of Insurance from the contractor and receipt of executed contract and performance, payment, and maintenance bond acceptable to the City Engineering and Legal Departments.
- 2. Payment of the City's administrative, inspection, and testing fees for the private construction contract.
- 3. Issuance of a City of Des Moines Grading Permit for Airport Business Park Plat 3.
- 4. Receipt of consent to construct the improvements from the property owner at the time of construction.

BE IT FURTHER RESOLVED: That permission be and is hereby granted to the parties of said contract to construct said Paving, Sanitary and Storm Sewer Improvements in accordance with said contract documents and subject to the following:

- 1. Receipt of Certificate of Insurance from the contractor and receipt of executed contract and performance, payment, and maintenance bond acceptable to the City Engineering and Legal Departments.
- 2. Payment of the City's administrative, inspection, and testing fees for the private construction contract.
- 3. Issuance of a City of Des Moines Grading Permit for Airport Business Park Plat 3.
- 4. Receipt of consent to construct the improvements from the property owner at the time of construction.
- 5. Inspection and approval by the Des Moines City Engineer.
