WHEREAS, the City of Des Moines annually enters into a Joint Funding Agreement with the U.S. Department of Interior U.S. Geological Survey for operation and maintenance for flood warning and river height gauging stations in the Des Moines and Raccoon River basins; and

WHEREAS, a proposed 28E Agreement for the cost sharing of gaging station operation and maintenance on the Raccoon River between the City of Des Moines, the City of West Des Moines, and Board of Water Works Trustees has been drafted and submitted for approval to West Des Moines and Water Works; and

WHEREAS, it is in the best interest of the City of Des Moines to approve 28E Agreement between the City of Des Moines, the City of West Des Moines, and Board of Water Works Trustees, City of Des Moines, Iowa, for payment for operation of a flood-warning and river-height gaging stations on Walnut Creek at 63rd Street in Des Moines (known as 1st Street in West Des Moines) and on the Raccoon River at 63rd Street, at the City of Van Meter, and at Fleur Drive:

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the Chapter 28E Agreement between the City of Des Moines, the City of West Des Moines, and Board of Water Works Trustees, City of Des Moines, Iowa, for payment for operation of flood-warning and river-height gaging stations on Walnut Creek at 63rd Street in Des Moines (known as 1st Street in West Des Moines) and on the Raccoon River at 63rd Street, at the City of Van Meter, and at Fleur Drive, a Copy of which is attached hereto and made a part hereof, is hereby approved as to form and content.
- 2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said chapter 28E Agreement for and on behalf of the City of Des Moines, Iowa.
