APPROVING AGREEMENT WITH THE U.S. DEPARTMENT OF THE INTERIOR GEOLOGICAL SURVEY FOR THE OPERATION AND MAINTENANCE OF FIVE (5) RIVER AND STREAM GAUGING STATIONS IN THE DES MOINES AREA


WHEREAS, the City of Des Moines annually enters into a Joint Funding Agreement with the U.S. Department of Interior U.S. Geological Survey for operation and maintenance for flood warning and river height gauging stations in the Des Moines and Raccoon River basins; and

WHEREAS, there is a separate proposed 28E Agreement for the cost sharing of gaging station operation and maintenance on the Raccoon River between the City of Des Moines, the City of West Des Moines, and Board of Water Works Trustees; and

WHEREAS, pursuant to the proposed 28E Agreement, the city of Des Moines will contribute \$37,340, the City of West Des Moines will contribute \$11,950, the Des Moines Water Works will contribute \$7,470 and the U.S. Geological Survey will contribute \$17,940 to cover budgeted costs for the period from October 1, 2010, to September 30, 2011, and

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached Agreement, in the amount of \$74,700 between the City of Des Moines and the U.S. Department of the Interior Geological Survey, which provides for the operation of the City's five (5) gauging stations, (63rd Street on Walnut Creek, Easton Boulevard on Four Mile Creek, Fleur Drive on the Raccoon River, 63rd Street on the Raccoon River and 2nd Avenue on the Des Moines River), is hereby approved, and;
