

ORDERING CONSTRUCTION OF 2011 CITY-WIDE PCC PAVEMENT RESTORATION PROGRAM AND FIXING A DATE FOR RECEIVING OF BIDS ON JUNE 14, 2011 AND PUBLIC HEARING ON JUNE 27, 2011 ENGINEER'S ESTIMATE IS \$224,500.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2011 City-wide PCC Pavement Restoration Program, 06-2011-009

The improvement includes furnishing, placing, curing, sawing, and sealing PCC Pavement Patches of various thickness in a cooperative effort with the City of Des Moines, Public Works Department, at the following locations:

E. 42nd Street from Hubbell Avenue to Boyd Street
SW 62nd Street from Tonka Avenue to Railroad Avenue
Adams Avenue from 34th Street to dead-end East
E. Douglas Avenue from E. 38th Street to E. 42nd Street
Kingman Circle from Kingman Boulevard to cul-de-sac South
SW Leland Avenue from Hwy 28 to SW 63rd Street
Park Lawn Avenue from SW 42nd Street to 1600' West
E. Rose Avenue from SE 15th Street to Indianola Drive
Twana Drive from 50th Street to 4928 Twana Drive
Walker Avenue from E. 29th Street to E. 30th Street

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$224,500.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on June 27, 2011, at which time this Council will consider any objections offered thereto or to the making of said improvement.
