**AMENDING THE CONTRACT PROCEDURES FOR HUD SUPPORTIVE HOUSING PROGRAM (SHP) AND SHELTER PLUS CARE (S+C) PROJECTS**

WHEREAS, by Roll Call No. 96-1034, dated March 18, 1996 regarding contract and amendment procedures for the Department of Housing and Urban Development (HUD) Consolidated Plan projects, the City council authorized and directed the City Manager to approve and execute the detailed work programs and written agreements with City Departments and sub-recipient entities implementing all projects contained in the City Council approved Consolidated Plan; and

WHEREAS, this action was approved in order to prioritize staff time and reduce administrative costs attendant to the development and approval of HUD-funded programs, which were part of plans and/or funding applications already approved by the City Council; and

WHEREAS, a substantial reduction in processing time was achieved by authorizing the City Manager to approve work programs and contracts for projects operated by City Departments or sub-recipients, since Council review and approval already occurs when the plans or applications are adopted; and

WHEREAS, City administrative and legal staff have reviewed federal regulations and City ordinances and have determined that the City Council can delegate to the City Manager the authority to approve the detailed work programs and written agreements with sub-recipients once the Council has approved the overall budget and objectives for each project in the HUD Consolidated Plan; and

WHEREAS, this procedure has been used consistently since 1996 in processing approval for work programs, written agreements, and amendments for the HUD Consolidated Plan projects and if approved for the SHP and S+C, will make it unnecessary to prepare Roll Calls, for approval of at least 45 sub-recipient agreements, HUD grant agreements, close outs and possible amendments for Council action.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Manager is authorized and directed to approve and execute the detailed work programs, written agreements, grant agreements, close out actions, and amendments with sub-recipient entities in accordance with City Council approval of the Supportive Housing Program and Shelter Plus Care applications and the projects listed therein.
