NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Sustainable Communities Regional Planning Grant Consortium Agreement, on file in the Office of the City Clerk, which document provides for the City's commitment of professional staff time is hereby approved and the Mayor is authorized and directed to execute such document on behalf of the City and the City Clerk is directed to attest to the Mayor's signature.

BE IT FURTHER RESOLVED that the City Manager or his designees are hereby directed to administer the allocation of professional staff time in accordance with the terms of the Consortium Agreement.
