FURTHER CONTINUANCE OF HEARING FOR CONVEYANCE OF A LICENSE AGREEMENT ON CITY-OWNED PROPERTY AT 1012 OAK PARK AVENUE (MCHENRY PARK) TO QWEST CORPORATION FOR \$200

WHEREAS, Qwest Corporation owns and operates fiber optic equipment and lines within the street right-of-way of Oak Park Avenue which lines must be relocated, and thus Qwest has requested a license agreement to use City-owned property at 1012 Oak Park Avenue (McHenry Park) for the relocation and for the placement of related utility equipment; and

WHEREAS, on April 25, 2011, by Roll Call No. 11-0676, it was duly resolved by the City Council that the proposed conveyance of the License Agreement be set down for hearing on May 9, 2011, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal to convey the License Agreement was given as provided by law, setting forth the time and place for hearing on the proposal; and

WHEREAS, on May 9, 2011, by Roll Call No. 11-0828, the hearing on said proposal was continued to May 23, 2011, upon request by Qwest Corporation and City staff; and

WHEREAS, further review is needed by Qwest Corporation and the City's Legal Department and Risk Manager regarding insurance documentation and other agreement terms, and a further continuance of the public hearing until the Council meeting on June 13, 2011 has been requested.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the public hearing for conveyance of a License Agreement with Qwest Corporation as described herein, be and is hereby continued to June 13, 2011, at 5:00 p.m. in the City Council Chambers.
