ORDERING CONSTRUCTION OF S.W. 9TH STREET AND DART WAY INTERSECTION IMPROVEMENTS AND FIXING A DATE FOR RECEIVING OF BIDS ON JUNE 21, 2011 AND PUBLIC HEARING ON JULY 11, 2011 ENGINEER'S ESTIMATE IS \$775,000.00

WHEREAS, this Council deems it advisable and necessary to construct the below referenced improvement, all in accordance with the plans and specifications, and has caused to be prepared plans, specifications, and form of contract, together with estimate of cost, which are now on file in the City Engineer's Office, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa 50309-1891, for public inspection for the construction of said improvements, and said plans, specifications and form of contract are deemed suitable for the making of said improvement, for which the State of Iowa Department of Transportation (IDOT) and the City of Des Moines, (CITY) have an agreement, previously approved by this Council, under which the IDOT has agreed to advertise, receive, open and tabulate sealed bids, and

WHEREAS, before said plans, specifications, form of contract, and estimated cost of the improvement may be approved, and contract for the construction of the improvement entered into, it is necessary to hold a public hearing.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

S.W. 9th Street and DART Way Intersection Improvements, 06-2011-004 STP-1945(782)--2C-77

The improvement includes the widening of DART Way at SW 9th Street, resurfacing SW 8th & SW 9th Street from the railroad viaduct (south of downtown) south to the Raccoon River Bridge with a 3-inch HMA overlay, traffic signal modifications at SW 9th Street & DART Way, pavement markings, and miscellaneous associated work including cleanup; all in accordance with the contract documents, including Plan File Nos. 527-149/172, located on DART Way at SW 9th Street, and SW 8th & SW 9th Street from the railroad viaduct to the Raccoon River Bridge, Des Moines, Iowa

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$775,000.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

Proposals received will be opened and tabulated by the Iowa Department of Transportation on June 21, 2011, after which the bids together with a report and recommendation of the Chief Civil Engineer, will be presented to City Council at its next meeting for action thereon.

BE IT FURTHER RESOLVED: That an appropriate Notice to Bidders and Notice of Public Hearing for said improvement be published in the Des Moines Register as provided and directed by Chapter 26 and/or 314, Code of Iowa.
