APPROVING AND AUTHORIZING THE EXECUTION OF FEDERAL AVIATION ADMINISTRATION AIP GRANT AGREEMENT, PROJECT NUMBER 3-19-0027-53 RECONSTRUCT PARALLEL TAXIWAY DELTA AND CONNECTING TAXIWAYS BRAVO AND CHARLIE (PHASE 1 – DESIGN ONLY) AT THE DES MOINES INTERNATIONAL AIRPORT.

WHEREAS, on November 18, 2010, the FAA provided written confirmation that in Federal FY 2011 the Des Moines International Airport is programmed for an AIP Grant of \$1,900,000.00 to design the reconstruction of Taxiway D and the connecting taxiways; and,

WHEREAS, on March 1, 2011, by resolution A11-034, the Airport Board authorized a professional services contract with Foth Infrastructure and Environment, LLC, in an amount not to exceed \$1,430,500 for professional design services in connection with the Taxiway D Reconstruction project; and,

WHEREAS, on March 16, 2011, FAA provided written confirmation that the engineering agreement with Foth Infrastructure was acceptable to design the project; and,

WHEREAS, on June 1, 2011, FAA provided a grant offer in the amount of \$1,358,975 requiring acceptance of the grant and grant assurances by June 24, 2011.
