## SET HEARING FOR VACATION AND CONVEYANCE OF THE REMAINING PUBLIC ALLEY RIGHT-OF-WAY LOCATED IN THE BLOCK BOUND BY VINE, WATER, MARKET AND SOUTHWEST 2<sup>ND</sup> STREETS TO WATERFRONT LODGING, INC. FOR \$39,856

WHEREAS, on July 27, 2009, by Roll Call No. 09-1315, the City Council received a recommendation from the City Plan and Zoning Commission that the remaining intervening public alley right-of-way located in the block bound by Vine, Water, Market and Southwest 2<sup>nd</sup> Streets, hereinafter more fully described, be vacated and sold subject to the site being developed in conformance with the City's Design Guidelines for the Court Avenue Historic Area as approved by the Urban Design Review Board and with a "D-R" District site plan as approved by the Plan and Zoning Commission; and

WHEREAS, Waterfront Lodging, Inc. is the purchaser of the property locally known as 101 Southwest 2<sup>nd</sup> Street that abuts such right-of-way and has offered to the City of Des Moines the purchase price of \$39,856 for the vacation and purchase of such right-of-way described below for the purpose of allowing the alley to be incorporated with surrounding properties for development, which price reflects the restricted use fair market value of the property as currently estimated by the City's Real Estate Division; and

WHEREAS, Waterfront Lodging, Inc., the City Real Estate Division and Legal Department have negotiated the Offer to Purchase Real Estate from the City of Des Moines and Acceptance ("Offer") which includes, among other terms, provisions that (1) the sale of this right-of-way is subject to a no-build restriction, (2) closing on the sale is subject to Waterfront Lodging, Inc. closing on the purchase of the adjoining property and (3) closing is subject to approval of the development plan for the property by the City Council; and

WHEREAS, there is no known current or future public need for the right-of-way proposed to be sold and the City will not be inconvenienced by the sale of said property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating the remaining intervening public alley right-of-way located in the block bound by Vine, Water, Market and Southwest 2<sup>nd</sup> Streets, more specifically described as follows:
