RESOLUTION APPROVING CONTRACT FOR A FORGIVABLE LOAN FROM IDED TO KEMIN INDUSTRIES, INC., TO ASSIST IN THE EXPANSION OF KEMIN'S CORPORATE HEADQUARTERS IN THE DES MOINES AGRIBUSINESS ENTERPRISE ZONE

WHEREAS, Kemin Industries, Inc. (hereinafter "Kemin") is proposing to invest approximately \$39,600,000 to implement its Five-year Capital Improvement Plan to expand its home office, research and manufacturing facilities at 2100 Maury and to retain 332 jobs and create 98 new jobs within the next five years within the City of Des Moines (collectively the "Kemin Project") subject to receipt of financial assistance from the State and City of Des Moines; and,

WHEREAS, on June 13, 2011, by Roll Call No. 11-1048, the City Council approved an Urban Renewal Development Agreement with Kemin Industries, Inc., whereby the City agreed to sell City-owned land needed for the expansion of the Kemin corporate campus, and to provide a Forgivable Loan and Economic Development Grant to Kemin in consideration of Kemin's agreement to undertake the Kemin Project; and,

WHEREAS, Kemin has been awarded a forgivable loan by the Iowa Department of Economic Development ("IDED") in the amount of \$1 million to assist it in the implementation of the Kemin Project, under the terms and conditions of the *Economic Development Financial Assistance Contract* between IDED, Kemin and the City, which is on file and available for public inspection in the office of the City Clerk; and,

WHEREAS, the City Manager recommends that the City Council approve the said *Economic Development Financial Assistance Contract* between IDED, Kemin and the City; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The *Economic Development Financial Assistance Contract* between IDED, Kemin and the City is hereby approved.
- 2. The Mayor is hereby authorized and directed to execute the *Economic Development Financial Assistance Contract* on behalf of the City and the City Clerk is hereby authorized and directed to attest to the Mayor's signature on such document.
- 3. The City Manager is authorized and directed to administer the *Economic Development Financial Assistance Contract* on behalf of the City and the timely performance of the City's obligations under that contract.
