APPROVING FINAL TERMS AND DOCUMENTS RELATING TO \$250,000 OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR COMPLETION OF REHABILITATION AND SITE IMPROVEMENTS AT THE MURILLO APARTMENTS AT 611 16TH STREET

WHEREAS, the City of Des Moines is considered an Entitlement City and receives Community Development Block Grant (CDBG) funds annually under 24 CFR 570; and

WHEREAS, rehabilitation of rental housing is an eligible CDBG activity and is consistent with the City's Consolidated Plan which was last amended by City Council by Roll Call No. <u>11-013</u> on January 28, 2011, and

WHEREAS, the Murillo Apartments at 611 16th Street, a building eligible for the National Register of Historic Places, was moved from its original location, and has sat unfinished and vacant for the two years due to financial problems; and

WHEREAS, by Roll Call 11-0689 at its April 25th, 2011 meeting, the City Council approved a preliminarily commitment to Murillo Flats, LLC of \$250,000 of Community Development Block Grant Funds;

WHEREAS, Murillo Flats, LLC., Ryan Galloway, 1312 Locust St. Des Moines, IA 50309 has purchased the building and site for \$175,000; and

WHEREAS, Ryan Galloway is an experienced developer of affordable housing who has a commitment from Banker's Trust on a first mortgage, is working with the Office of Economic Development on Enterprise Zone Credits and will invest \$100,000 of owner's equity in the structure; and

WHEREAS, Mr. Galloway has met with the surrounding property owner's pursuant to City Council direction; and

WHEREAS, the financing of the City loan will be in compliance with all CDBG regulations under 24 CFR 570, including a five-year affordability requirement for four of the units and all construction and affordability monitoring; and

WHEREAS, the City's funding is proposed to be a \$210,000 loan at 0% interest rate amortized over twenty years with payment to begin in June of 2012 and a grant of \$40,000 to cover affordability for four of the five years; and
