RESOLUTION TO APPROVE THE NEIGHBORHOOD STABILIZATION PROGRAM 3 (NSP3) CONTRACT AND RELATED SUPPORTING DOCUMENTS WITH THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, Section 2301 of the Housing and Economic Recovery Act of 2008 created the Neighborhood Stabilization Program (NSP); and,

WHEREAS, Section 1947 of the Wall Street Reform and Consumer Protection Act created the Neighborhood Stabilization Program 3 (NSP3); and,

WHEREAS, Congress allocated \$2 billion of Community Development Block Grant funds to the NSP for state and local governments to provide emergency assistance redeveloping abandoned and foreclosed homes; and,

WHEREAS, the State of Iowa received \$5 million to allocate to cities within the State; and,

WHEREAS, the State of Iowa submitted a plan to HUD which allocated \$1 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa to outline how to allocate these funds; and,

WHEREAS, the State of Iowa approved the City's plan to allocate the funds; and.

WHEREAS, the State of Iowa requires Cities to update their Residential Antidisplacement and Relocation Assistance Plan (RARAP) and policy panning Excessive Force as a part of the State's Consolidated Plan.
