RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION FOR THE LIBERTY BUILDING HYATT PLACE HOTEL RENOVATION IMPROVEMENTS METRO CENTER URBAN RENEWAL PROJECT

WHEREAS, on April 12, 2010, by Roll Call No. 10-558, the City Council of the City of Des Moines approved a First Amendment to Urban Renewal Development Agreement ("Development Agreement") with Liberty Building Development Group, L.L.C. ("Liberty") wherein Liberty has undertaken Hotel Renovation Improvements on floors four through eight and portions of the basement and floor one of the Liberty Building on property described as:

Lots 7 and 8, Block B in Commissioners Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa ("Liberty Property").

WHEREAS, the terms of the Development Agreement provide that the City shall issue the Certificate of Completion upon the City's determination of satisfactory completion of the Liberty Property Commercial Component Improvements consisting of the Hotel Renovation Improvements and Liberty has requested that the Certificate of Completion for such Hotel Renovation Improvements be issued; and

WHEREAS, City staff has inspected the Hotel Renovation Improvements and found the Improvements have been completed in substantial compliance with the terms of the Development Agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. The City Council hereby finds and acknowledges that Liberty has satisfied its obligation to construct the Hotel Renovation Improvements on the Liberty Property in substantial compliance with the provisions of the Development Agreement and the approved Construction Plans.
- 2. This resolution shall constitute the issuance of a Certificate of Completion for the Hotel Renovation Improvements on the Liberty Property in accordance with Section 25 of the Development Agreement. Pursuant to Section 26 of the Development Agreement, the obligations and covenants contained in the Development Agreement with respect to construction of the Hotel Renovation Improvements on the Liberty Property, and the dates for the beginning and completion thereof, are hereby deemed satisfied and terminated.

- 4. The City Clerk is hereby directed to cause a certified copy of this resolution to be recorded in the land records of the Polk County Recorder, with such recording costs to be repaid by Liberty either directly or as a deduction from an installment of the Additional Economic Development Grant.
