RESOLUTION APPROVING LICENSE AGREEMENT WITH DES MOINES APARTMENTS, LP, FOR ACCESS TO THE DES MOINES BUILDING

WHEREAS, on July 11, 2011, by Roll Call No. 11-1251, the City Council selected the proposed submitted by Nelson Development and Construction (represented by Mike Nelson), and Foutch Brothers LLC (represented by Steve Foutch), as the preferred proposal for the redevelopment of the Des Moines Building at 405 6th Avenue and 513 Locust Street, and designated Nelson Development and Construction and Foutch Brothers LLC, or their designee, as the preferred redevelopment of the redevelopment of the Des Moines Building; and,

WHEREAS, Nelson Development and Construction, and Foutch Brothers LLC have established Des Moines Apartments, LP, a Missouri limited partnership, as their business entity to undertake the redevelopment of the Des Moines Building; and,

WHEREAS, Des Moines Apartments, LP, has requested access to the Des Moines Building for inspection and testing purposes in preparation for preparing plans for the redevelopment of the building; and,

WHEREAS, the City Manager recommends that the City grant Des Moines Apartments, LP, access to the Des Moines Building upon the terms of the *License Agreement for Property* Access which is on file and available for public inspection in the office of the City Clerk; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The *License Agreement for Property Access* with Des Moines Apartments, LP, is hereby approved.
- 2. The Mayor is hereby authorized and directed to execute such agreement on behalf of the City of Des Moines, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature on such document.
