AUTHORIZATION TO PROCEED WITH ACQUISITION OF THE NECESSARY PROPERTY INTERESTS FOR THE 2011 AND 2012 SEWER REPAIR PROJECT BY GIFT, NEGOTIATION, OR CONDEMNATION

WHEREAS, the City's Engineering Department has determined that it is necessary to acquire right-of-way in connection with the 2011 and 2012 Sewer Repair Project; and

WHEREAS, on May 23, 2011, the City Council approved professional services agreements with Foth Infrastructure and Environment, LLC by Roll Call No. 11-0871 for Sewer Repair Contract 1 and Snyder and Associates, Inc. by Roll Call No. 11-0872 for Sewer Repair Contract 2, respectively, for design and construction phases of the 2011 and 2012 Sewer Repair Project; and

WHEREAS, on August 29, 2011, by Roll Call No. 11-1432, the City Council approved supplemental agreement No. 1 with Foth Infrastructure and Environment, LLC, for design and construction services for the Sewer Repair Contract 1 Project; and

WHEREAS, in order to meet the construction deadline to potentially become eligible for funding by the Federal Emergency Management Agency (FEMA), it may be necessary to exercise the optional Right-of-Way Acquisition Services under either or both of the Professional Services Agreements; and

WHEREAS, after the design is completed and right-of-way needs are determined, the proposed fair market value of the property interests to be acquired will be submitted to the City Council or the City Manager, as applicable, for approval and authorization to proceed with the acquisitions.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. That the City Manager be and is hereby authorized to proceed with the necessary activities and negotiations to acquire by gift, negotiation, or condemnation the necessary property interests for construction of the 2011 and 2012 Sewer Repair Project, subject to approval by this Council, or approval of the City Manager in accordance with Section 2-201 (c) and (d), of the Municipal Code of the City of Des Moines, Iowa, as appropriate.
- 2. That the property will be acquired in accordance with the guidelines of 49 CFR Part 24 of the Uniform Relocation and Real Property Acquisition Act, as revised, and that relocation assistance is hereby authorized.
- 3. That the fair market value of these parcels will be approved in accordance with established City policy. If the property owners agree to convey the property to the City in an amount based on the
