**APPROVING INITIAL LIHEAP (LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM)
CONTRACT WITH THE IOWA DEPARTMENT OF HUMAN RIGHTS, DIVISION OF
COMMUNITY ACTION AGENCIES FOR ENERGY-RELATED ASSISTANCE FOR
LOW-INCOME PERSONS FROM OCTOBER 1, 2011 TO SEPTEMBER 30, 2012**

WHEREAS, Des Moines Community Action Agency, Housing Services Department, administers the Low-Income Home Energy Assistance Program (LIHEAP); and

WHEREAS, the Iowa Department of Human Rights, Division of Community Action Agencies has now forwarded Contract No. LIHEAP-12-07-J on file with the City Clerk as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, Contract No. LIHEAP-12-07-J, by and between the Iowa Department of Human Rights, Division of Community Action Agencies and the City of Des Moines, allocates \$123,407 to the City of Des Moines for the provision of energy-related assistance to low income persons during the period from October 1, 2011 through September 30, 2012; and

WHEREAS, approval of Contract No. LIHEAP-12-07-J is in the best interest of the City as it will provide for the increase in energy-related assistance available for low-income residents of Des Moines; and

WHEREAS, at its meeting on September 21, 2011 the Housing Services Board recommended that the City Council approve Control No. LIHEAP-12-07-J with a total contract budget of 123,407.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that Contract No. LIHEAP-12-07-J, with a total contract budget of \$123,407, is hereby approved.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized and directed to execute the above-referenced contract and the City Clerk to attest to his signature.
