**RESOLUTION TO GIVE PRELIMINARY APPROVAL FOR A
 NEIGHBORHOOD COMMERCIAL REVITALIZATION PROGRAM PREDEVELOPMENT GRANT IN
 THE AMOUNT OF \$5,000 AND A FAÇADE GRANT
 IN THE AMOUNT OF \$15,000 FOR RENOVATIONS
 TO 210 COURT AVENUE, DES MOINES**

WHEREAS, Jeffery C. and Pamela K. Baker. (hereinafter referred to as Developer) 661 42nd Street, Des Moines, have made an application for a Neighborhood Commercial Revitalization (NCR) Program Predevelopment Grant in the amount of \$5,000 and a Façade Grant in the amount of \$15,000; and

WHEREAS, Council is considering preliminary approval of such funding subject to the finding of eligibility by staff under all environmental reviews and program requirements; and

WHEREAS, the proposed project will assist in revitalizing vacant commercial space in the Historic Court Avenue District and the Metro Center Urban Renewal Area by enhancing the value of the commercial property within the area.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that preliminary approval is given for a NCR Predevelopment Grant in the amount of \$5,000 and a NCR Façade Grant in the amount of \$15,000.00 under the terms and conditions as outlined in the City Council communication, which by this referenced is made a part hereof, with such loan contribution to be expressly contingent upon meeting all environmental review requirements and NCR program requirements.

BE IT FURTHER RESOLVED that in the event that any project parameters materially change, the City Manager or his designee is directed to make a recommendation to the Council as to whether the proposed City contribution is necessary or appropriate, and as to whether the terms of the City's contribution should be renegotiated.


