**RESOLUTION AUTHORIZING CITY MANAGER TO SIGN FUTURE AMENDMENTS  
OF ATTACHMENT A TO THE NEIGHBORHOOD STABILIZATION CONTRACT  
BETWEEN THE CITY OF DES MOINES AND THE IOWA DEPARTMENT OF  
ECONOMIC DEVELOPMENT**

WHEREAS, Section 2301 of the Housing and Economic Recovery Act of 2008 created the Neighborhood Stabilization Program (NSP); and,

WHEREAS, Congress allocated \$3.92 billion of Community Development Block Grant funds to the NSP for state and local governments to provide emergency assistance redeveloping abandoned and foreclosed homes; and,

WHEREAS, the State of Iowa submitted a plan to HUD which allocated \$4.2 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa stating how the city would use these funds; and,

WHEREAS, the State of Iowa approved the City's plan to use the funds; and,

WHEREAS, many of the projects funded with NSP are being completed; and,

WHEREAS, final costs for each of these projects vary slightly from previously budgeted amounts; and,

WHEREAS, many of these contract amendments will be minor in nature, involving less than 10% of the total project budget; and

WHEREAS, each reallocation of funds between activities requires the City to amend Attachment A of the Neighborhood Stabilization Program 1 contract with the Iowa Department of Economic Development.




