AUTHORIZING THE PURCHASE OF ONE ACRE WETLAND MITIGATION CREDIT FROM DALLAS COUNTY, IOWA VOAS MITIGATION BANK, FOR \$25,000.

WHEREAS, the City has accepted completed construction of Closes Creek-Nierob Court Stormwater Improvements (Activity ID 08-2004-002) and Closes Creek Watershed – 26th Street Detention and Storm Improvements (Activity ID 08-2005-007); and

WHEREAS, the United States Army Corps of Engineers Has determined that a combined total of 1 acre of wetland mitigation is required by said projects covered by Nationwide Permit Number 43 as provided for by Section 404 of the Clean Water Act; and

WHEREAS, the United States Army Corps of Engineers approved the use of the Voas Mitigation Bank in Dallas County for the wetland mitigation required for said projects; and

WHEREAS, on august 2, 2011 by Resolution No. 22011-0082, the Dallas County Board of Supervisors approved the sale of a one acre wetland mitigation credit from the Voas Mitigation Bank to the City of Des Moines, Iowa, to be granted upon receipt the City's payment of \$25,000.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the purchase of one acre of wetland mitigation credit from the Dallas County, Iowa Voas Mitigation Bank, at a total cost of \$25,000, is hereby approved and the Public Works Director is authorized and directed to take all necessary action to complete such purchase.


