APPROVING TERMINATION AGREEMENT FOR UNITED PARCEL SERVICE, INC. LEASES AT THE AIRPORT

WHEREAS, on October 18, 1999, the City and United Parcel Service, Inc. entered into a Land Lease for Parcel Distribution Facility (the "Land Lease"). The Land Lease has been amended five times: the First Amendment on January 8, 2001; the Second Amendment on April 22, 2002; the Third Amendment on December 8, 2003; the Fourth Amendment on February 7, 2005; and the Fifth Amendment on May 22, 2006; and

WHEREAS, on July 3, 2001, the parties entered into a lease entitled 2870 "old" Army Post Road Lease (the "2870 Lease"). The 2870 Lease has been amended twice: the First Amendment on December 8, 2003; and the Second Amendment on October 3, 2006; and

WHEREAS, on February 5, 2002, the parties entered into a lease entitled Lease Agreement (the "3251 Lease"). The 3251 Lease has been amended twice: the First Amendment on December 8, 2003; and the Second Amendment March 26, 2007; and

WHEREAS, UPS initially planned to construct a parcel distribution facility utilizing the properties covered by the three leases listed above; and

WHEREAS, UPS no longer intends to construct the parcel distribution project on the properties and wishes to terminate all three leases; and

WHEREAS, UPS and Airport staff have negotiated a Termination Agreement For United Parcel Service, Inc. Leases whereby, upon UPS paying the City \$12,333,000, the three leases will be terminated; and

WHEREAS, of the \$12,333,000, \$7,333,000 would be placed in Airport funds; and

WHEREAS, the Des Moines International Airport Board at its October 4, 2011, meeting passed a resolution recommending approval of the Termination Agreement; and

WHEREAS, the Council believes it is in the interests of the City to terminate the leases upon the terms set out in the proposed agreement.
