WHEREAS on September 12, 2011 by Roll Call No. 11- 1602, the City Council approved Ordinance No, 15046 which contains a series of amendments to the Zoning Code, Municipal Code Chapter 134, designed to regulate the sale of alcohol in Des Moines in response to a recent amendment to Chapter 123 of the Code of Iowa which eliminated the statutory prohibition against issuance of a class E liquor license to any premises at which gasoline is sold; and

WHEREAS, after further review by staff concerning the provisions enacted by Ordinance No, 15046, it was determined that amendments to that ordinance should be made to clear up certain ambiguities which might arise concerning the sale of alcoholic liquor in the C-1, C-2 and more restrictive zoning districts; and

WHEREAS, on October 10, 2011 by Roll Call No. 11-1707, the City Council duly resolved that a public hearing on the proposed text amendments be held on October 24, 2011 in Council Chambers, City Hall in Des Moines, Iowa, at which time those persons both in favor of and opposed to the proposed amendments would be heard; and

WHEREAS, notice of the public hearing was published in the Des Moines Register on October 13, 2011 pursuant to Iowa Code Section 362.3; and

WHEREAS, in accordance with the published notice, those interested in the proposed text amendments to Chapter 134 of the Municipal Code of the City of Des Moines, both for and against, have been given the opportunity to be heard with respect thereto and have presented their views to the City Council.
