APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR STORM SEWER IMPROVEMENTS, 2201 FOREST AVENUE, BETWEEN GATOR EXCAVATING, INC. AND HUBBELL CONSTRUCTION SERVICES

WHEREAS, on May 9, 2011 under Roll Call No. 11-0776, the City Council approved a private construction contract in the amount of \$15,460.50, between Gator Excavating, Inc., Kevin Henter, President, 5640 Miehe Drive, Grimes, IA, 50111 - as Contractor, and Hubbell Construction Services, Rick Tollakson, CEO, 6900 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as construction of storm sewer and related appurtenances near 2201 Forest Avenue, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 511-137, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$0.00, which have been constructed in substantial compliance with the contract documents between Gator Excavating, Inc. and Hubbell Construction Services, which were approved under Roll Call No. 11-0776, dated May 9, 2011, be received and filed; and that completion of said Storm Sewer Improvements described as construction of storm sewer and related appurtenances near 2201 Forest Avenue, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 511-137, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
