WHEREAS, on May 3, 2004, by Resolution No. 04-868, the Municipal Housing Governing Board approved the policy for the reduction of the term of forgivable second 5(h) Homeownership mortgages to conform with the current seven year requirement; and

WHEREAS, Lynn Krueger (Borrower) purchased the property locally known as 7540 Southview Drive, Des Moines, (the Property) and the Municipal Housing Agency holds a second mortgage on the property; and
