APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR STORM SEWER IMPROVEMENTS, 5625 FRANKLIN AVE.,
BETWEEN GATOR EXCAVATING, INC. AND SEPTAGON CONSTRUCTION COMPANY

WHEREAS, on April 25, 2011 under Roll Call No. 11-0657, the City Council approved a private construction contract in the amount of \$52,311.00, between Gator Excavating, Inc., Kevin Henter, President, 5640 Mieke Drive, Grimes, IA, 50111 - as Contractor, and Septagon Construction Company, Brad Leonard, President, 5704 Gateway Drive, Grimes, IA, 50111 - as Owner, for construction of Storm Sewer Improvements described as construction of two Type M-A Manholes, placement of storm sewer to connect to existing storm sewer in Merklin Way, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 498-154, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$52,311.00, which have been constructed in substantial compliance with the contract documents between Gator Excavating, Inc. and Septagon Construction Company, which were approved under Roll Call No. 11-0657, dated April 25, 2011, be received and filed; and that completion of said Storm Sewer Improvements described as construction of two Type M-A Manholes, placement of storm sewer to connect to existing storm sewer in Merklin Way, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 498-154, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.

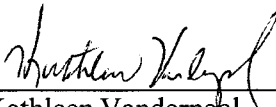

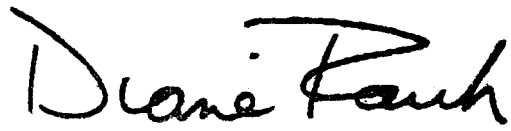
