## **RESOLUTION RELEASING SUBDIVISION BOND** FOR PRAIRIE HILLS OF DES MOINES PLAT 1

WHEREAS, on August 11, 2008, by Roll Call No. 08-1413, the City Council approved the subdivision plat entitled PRAIRIE HILLS OF DES MOINES PLAT 1 for land located in the vicinity of the 2600 block of E. Payton Avenue, to be developed by Prairie Hills of Des Moines LLC. Tim Hildebrandt (Officer); and,

WHEREAS, by said Roll Call, the City Council further authorized the approval and acceptance of Subdivision Bond numbers IAC 91259 and IAC 55723 from Merchants Bonding Company in the amounts of \$18,656 and \$31,232 as security for the estimated cost of sidewalk improvements, site erosion control, sanitary and storm sewers, and as-built survey costs; and,

WHEREAS, the City Engineer has certified that the required grading, site restoration, and public sidewalk, sanitary and storm sewer improvements have been completed and recommend that the security be released; NOW THEREFORE,

BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- Subdivision Bond Nos. IAC 91259 and IAC 55723 in the amounts of \$18,656 and 1. \$31,232 from Regal Construction Services, L.L.C., and Merchant's Bonding Company, are hereby released as security for the satisfactory completion of the remaining subdivision improvements.
