APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR SANITARY SEWER IMPROVEMENTS, 4200 ML KING JR. PARKWAY,
BETWEEN HALBROOK EXCAVATING, INC. AND TAI VILLAGE, INC.

WHEREAS, on October 26, 2009 under Roll Call No. 09-1907, the City Council approved a private construction contract in the amount of \$2,750.00, between Halbrook Excavating, Inc., Larry A. Halbrook, President, 4807 SE Rio Court, Ankeny, IA, 50021 - as Contractor, and Tai Village, Inc., Leunh Baccam, President, 1620 Pleasant Street, Suite 245, Des Moines, IA, 50314 - as Owner, for construction of Sanitary Sewer Improvements described as sanitary sewer manhole north of ML King Jr. Parkway and east of Madison Avenue to service the Tai Village Administration Building at 4200 ML King Jr. Parkway in accordance with the contract documents including Plan File No. 509-15, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Sanitary Sewer Improvements in the amount of \$2,750.00, which have been constructed in substantial compliance with the contract documents between Halbrook Excavating, Inc. and Tai Village, Inc., which were approved under Roll Call No. 09-1907, dated October 26, 2009, be received and filed; and that completion of said Sanitary Sewer Improvements described as sanitary sewer manhole north of ML King Jr. Parkway and east of Madison Avenue to service the Tai Village Administration Building at 4200 ML King Jr. Parkway in accordance with the contract documents including Plan File No. 509-15, is hereby acknowledged and that said Sanitary Sewer Improvements are hereby accepted.


