BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer, showing the cost of the construction of the 45th Street Resurfacing - South of Grand Avenue, 06-2010-002, in accordance with the contract approved between Grimes Asphalt & Paving Corp., Kurt Rasmussen, President, 5550 NE 22nd Street, Des Moines, IA 50313, under Roll Call No. 10-1416, of August 23, 2010, and the City of Des Moines, and recommending the acceptance thereof, be and the same is hereby approved, and accepted, and

BE IT FURTHER RESOLVED: That \$378,662.93 is the total cost, of which \$353,289.10 has been paid the Contractor, and \$6,440.68 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$18,933.15 is to be paid at the end of thirty days, with funds retained for unresolved claims on file in accordance with Iowa Code Chapter 573.

BE IT FURTHER RESOLVED: That the Des Moines Finance Director be and is hereby authorized to release said retainage if suit is not filed as above provided.
